**CREDIT TERMS**

In consideration of the processing by Golden State Crushing of this application and/or extension of credit to applicant, if so decided by Golden State Crushing and/or the making of any sale to applicant (if so decided by Golden State Crushing) Applicant agrees as follows:

- 1.) All charges are due and payable as terms approved by the credit department. All bills are payable to Golden State Crushing.
- 2.) In the event the account is not paid in full, as provided in "Paragraph 1" above applicant agrees to pay Golden State Crushing a late fee in the sum of 1.5% per month (which is annual percentage rate of 18%) on all amounts not paid by the last day of the month in which payment was due.
- 3.) In the event Applicants account is past due, Applicant agrees to pay Golden State Crushing Sacramento California, any and all court cost, attorney fees, or collection fees, expert witness fees, or other collecting cost that may be incurred in collecting any sums due on Applicants account or in enforcing Golden State Crushing right to payment.
- 4.) Applicant agrees fully and promptly to furnish Golden State Crushing all information necessary for the acquisition and maintenance of mechanics liens, stop notices, and bond rights. Such information shall include, but not limited to, construction lender, accurate property description, name, and address of owner and Account Payable Numbers.
